- Nursing Skills: Injections, IV insertion and care; IV medication administration; PICC line/Central Line care; NG/G-tube/J-tube care and medication administration; tracheostomy care/suctioning; Foley catheter insertion/care; wound vac care; various skin/wound treatments.

**Charge Nurse:** Oversee the entire facility, including 300+ residents, in addition to supervising unit and staff; address medical issues/questions from residents, families, and staff members; handle scheduling conflicts and address other facility concerns as needed.
