Our unit is an overflow progressive care unit that is trained to care for other patients from other progressive unit floors such as heart failure and medical surgical patients. All patients are on a tele monitor therefore we are required to re-certify in ECG testing two times per year. Required to print

and analyze strips each day for all patients. Use skills daily to recognize the signs and symptoms of cardiopulmonary emergencies and must initiate standardized interventions to stabilize the patient awaiting transfer to critical care including cardioversion, defibrillation and transcutaneous pacing. Experience with the assessment of ventilated patients to ensure delivery of the prescribed treatment and patient response including tracheostomy care, and continuous and intermittent SpO2 monitoring. Experience with the monitoring of patients using standardized procedures for pre, intra, and post procedures (i.e., cardioversion, TEE, cardiac catheterization with PCI, bronchoscopy, EGD, PEG placement, chest tube insertion). Experience with recognition of the signs and symptoms of cardiopulmonary emergencies and initiate standardized interventions to stabilize the patient awaiting transfer to critical care including cardioversion, defibrillation and transcutaneous pacing. Experience with the recognition of indications for and management of patients requiring non-invasive O2 delivery systems including oral airways, BIPAP, nasal, and CPAP.
