 The antiphospholipid and antinuclear question required a little more thought for someone who hasn't used or heard that medical terminology in over 10 years of clinical practice as an ED nurse. It seemed like a strangely impertinent and time wasting question for such a short clinical assessment.
The sickle cell question. I've been an ED nurse for over 10 years treating in an area with a population prone to this condition. At the most I may have treated patients experiencing a truly debilitating sickle cell crisis 5 times or less. It's just not that common and is managed differently now.
The test advanced just prior to, and seemingly simultaneous to clicking advance not allowing me to answer questions I knew were correct.

4. Other than needing a fraction of a second more to answer and substituting a few more clinically relevant questions, I'm confident I would have scored as highly proficient or expert.
