PEDIATRIC INTENSIVE CARE UNIT, CAPITOL MEDICAL CENTER January 2005 to April 2006

The Pediatric Intensive Care Unit is a 10-bed capacity. We treated children ranging from 1-18 years of age with critical conditions that needing one on one monitoring or critically ill and intubated pediatric patients. The cases I have dealt with the times I worked there that really struck me were vehicular/motor accidents, stampede survivors, poisoning, children with cardiac problems, diabetes and pulmonary problems. We worked 1:1 and for rare cases 2:1 patient ratio depending on the severity of the case. Total nursing care was rendered to the patients. We worked side by side with the Pediatricians and Pediatric Residents and Interns.

We carried out our own orders as directed by the doctors, communicated with the doctors for any changes with the clients present whether they may be improvements or the case is deteriorating. In cases that we do not have census, I got floated to pediatric ward/unit. I got to experienced how to take care of kids who are sick with respiratory problems like asthma, cough and colds, URTI, and the likes. I also managed kids with fractures, fever, gastroenteritis and medically inclined pediatric diseases.
