- Performing a thorough chart review using Epic prior to meeting the patient to gather data for eligibility.
- A physical assessment of the patient
- Triaging with Agrace physicians to determine eligibility for hospice based on medicare guidelines, chart review and physical assessment.
- If eligible, the writer then completes a medication reconciliation, and identifies immediate needs for the patients, much as DME, medications, nurse visits in the evening etc.
- Educates family on what hospice is and how Agrace can help support the patient and family.

Worked as a circulator in the operating room for spine, general, orthopedic, urology, ENT, eye and gynecological surgeries. Patients range from infant to adult. Overall responsibility is to manage the OR suite during the entire procedure. This includes:

- Headed up the spine program and was the lead RN for spine surgeries.
- Helping anesthesia with sedation and/or intubation.
- Making sure the patient is positioned and prepped correctly for surgery.
- Counting before and after the case with the scrub tech.
- Troubleshooting equipment, running for supplies during the case.
- Often was given the role of facilitator, which means supervising all OR staff and OR suites, maintaining the daily schedule, staffing assignments, giving breaks and lunches.
