- Demonstrates knowledge and application of the nursing process.

- Participates and cooperates in the unit based Quality Improvement processes.
- Supports, maintains and provides an environment which is supportive of quality patient care through effective use of resources and personnel.

- Provide direct quality care for 6-7 patients per day to include daily continued monitoring, recording and evaluation of medical conditions.

Wound care to include dressing changes, monitoring of wound-vac, hemovac, Jackson-Pratt drainage systems. IV insertion/management and discontinuation; PICC/central line care and management, blood draws and monitoring site. Port-a-cath accessing/deaccessing care and monitoring. Blood transfusions and monitoring; tracheostomy care and management; BIPAP/CPAP use and monitoring; oxygen therapy; chest tube and drainage system care and management; telemetry offsite patient monitoring/recording; feeding tube care and management; Foley insertion, care and removal.
