### **Registered Nurse Manager**

My duties as a RN nurse manager were the same as a LPN's such as: passing medication, addressing sick call slips, collaborating with the other members on the nursing staff and members of the jail staff. Also, addressing emergency situations that happened in the jail setting. Accurate documentation and charting on events that occurred were extremely important.

As the RN nurse manager my responsibilities also included: working closely with the mental health professional to ensure proper treatment was being given to the patient's that needed it. It was also my job to make appointments for patients that needed treatments outside of the jail setting. I was also responsible for ordering supplies and stock medications that we kept on hand to be given out in emergency situations. It was my job to fill out the schedule to make sure that all shifts were covered. As the manager, it was my responsibility to hire new employees, help them fill out the new hire paperwork and orientate them to their new work environment and responsibilities.

### **LPN (Licensed Practical Nurse)**

Advanced Correctional Healthcare - West Bend, WI

January 2017 to August 2017

I was responsible for medication passes. It was also my responsibility to assess inmates that put in sick call slips to be seen. After the assessments I would contact the jail physician with my findings and the physician would treat the inmate accordingly. Inmates would come in withdrawing from medication and/or illegal drugs and I would have to help detox that patient. I would also respond to emergent situations, if

a patient would have a medical emergency it was the nursing staff's job to maintain the patient's stability and send them out to the hospital where they could receive further care.

It was important to be able to work together closely with the jail and nursing staff team. It was also very important to be able to have detailed and accurate charting to maintain continuity of care and to be able to call the hospital and give detailed information to them. The nursing staff was also responsible for ordering the medications needed at the site. If the medications that were needed were life sustaining such as cardiac meds or diabetic meds for example they had to be emergency ordered. The ability to have good communication skills both verbal and written were essential in this job setting.

Critical thinking and the ability to multitask were also 2 skills that had to be performed on a daily basis.

My job is to provide care for my client who has muscular dystrophy which requires her to have a trach and gastrostomy tube. I provide all of her ADL cares and medical treatments.
