I monitor residents and do data collection (urine samples, pain assessments, skin assessments, fall-risk data). I do catheter care. I schedule appointments as needed for resident care. I update plan of care for residents. I supervise certified nursing assistants and assist as needed with transfers, cares, etc. I communicate with family and MD regarding residents. We do small procedures when ordered such as: insertion/removal of catheter, ear flush, suture removal. I update MD with any concerns regarding residents and obtain verbal orders and transcribe them.
