Baseline Data/Explanation:

This unit based project intended to improve compliance with admission documentation and patient safety and awareness surrounding HIV testing after a recent decline in HIV audits. *Interventions:*

As the HIV champion, an HIV Audit Checklist was developed to monitor HIV completion and to follow up on incomplete charts. Staff was also re-educated through Thursday morning huddle (Dec. 22, 2016) and Shared Governance (Jan. 5, 2017) *Outcomes:*

Through re-education of staff and daily chart audits, by the charge nurse, which utilized the HIV checklist, the goal to increase documentation and patient safety and awareness was met.
