Urgent Care

Assessments for workers compensation including diagnosis, imaging, diagnostics, referrals to other specialties or more advanced diagnostics, coordinating plan of care with work comp nurse as well as patient's work facility HR department, filling out work comp paperwork
Documentation to support findings on assessments that is thorough, accurate and detailed
See and diagnose all ages from birth to elderly
