- Responsible for preparing both the surgical room and the patient for surgery.
- Set up the operating room by sterilizing and laying out the necessary surgical instruments, hanging clean curtains and sheets, and prepping solutions for the surgeon.
- Assemble any of the equipment that will be used during surgery, check for any malfunctions, and make any needed adjustments.
- Prepare the patient by washing, shaving, and sterilizing the site of the surgery.
- Assist with the moving of the patient to the operating room and position them correctly on operating table.
- Aides the surgeon in controlling blood flow and protecting the patient from exposure.
- Consults and coordinates with health care team members to assess, plan, implement and evaluate patient care plans.
- Conducts pre- and post-operative education.
- Serves as the communication liaison to family and members of the operating team.
- Takes and monitors patients' vital signs.
- Ensures that operating on correct patient and the correct procedure is being performed
- Provides basic, bedside care
- Prepares and administers (orally, subcutaneously, through an IV) and records prescribed medications.
- Reports adverse reactions to medications or treatments in accordance with the policy regarding the administration of medications by a licensed registered nurse
- Responds to life-saving situations based upon nursing standards and protocol

- Records all care information concisely, accurately and completely, in a timely manner, in the appropriate format and on the appropriate forms
- Preps operating room for patient/procedure
- Initiates corrective action whenever information from monitoring equipment shows adverse symptomatology
- Monitors patients' physical and emotional well-being throughout the care continuum
- Initiates patient education plan, as prescribed by physician. Teaches patients and significant others how to manage their post-treatment home care needs, self-administration of medication and rehabilitation.
- Performs other position-related duties as assigned, depending on assignment setting.
- Decontaminates and sterilizes instruments, medical supplies and equipment, and assembles wraps and sterilizes trays of instruments.
- Follows proper Standard Precautions while in decontamination and sterilization areas
- Monitors biological and chemical wash solution to ensure quality and consistency for decontamination of instruments and medical equipment
- Sorts mismatched sets of instruments, trays, and medical equipment and makes them available to sterile processing customers in a timely manner
- Restocks, labels, and maintains inventory, submits requisitions, collects and distributes instruments, trays, crash carts, and facility medical equipment
- Performs environmental maintenance duties and assists in maintaining inventory levels in sterile processing, the operating room, and in equipment storage areas
- Verifies that equipment functions properly, requisitions for equipment maintenance, repair or replacement, and removes defective equipment
