Medically complex patients to be treated in long-term care settings Vibra Hospital is a LTAC facility. I have worked at community health link which was a homeless outreach program Monday through Friday where clients with substance abuse and mental health issues would come to seek medical treatment in an outpatient setting. These clients were less fortunate and most didn't have health insurance but I loved everything about what this program did to help the community we would even go to homeless shelter to administer hepatitis vaccines. I also worked at Worcester state hospital where I worked with teenagers in an inpatient setting administering medications. Most of the kids were ages 12-18 that were in DCF custody and had endured some sort of trauma such as rape/molestation. These kids were destructive to themselves wanting to die dealing with PTSD along with severe depression, anxiety, and bipolar. Providing a therapeutic environment and focusing on safety was the most important thing everyday. Recently I have been employed at Whittier on a telemetry unit. These patients are medically complex with many different diagnoses. I complete head to toe assessments along with documentation, pass medications, and complete all treatments. Other nursing skills I do there are IV medications, g-tube feedings, and blood transfusions.

I worked Friday through Sunday 12 hour shifts at Hospital for behavioral medicine completing all their admissions. This hospital was an acute care inpatient treatment center for all ages. It consisted of 5 units for adolescents, adults, and geriatric patients who suffered from substance abuse and psychiatric issues. There I would work intake completing all assessments on the patient's being admitted to the hospital

and worked closely with doctors to ensure medical orders were put into the computer system. I would go to every unit and conduct chart audits on all patient's to ensure all documents were completed properly by nurses.

I completed accident/incident reports, quarterly assessments, and ensured documentation was completed properly by all the staff on my unit. Once a week the wound doctor would come I rounded with him to see patient's with wounds to make sure they were receiving proper treatment to heal their wounds. I would schedule appointments in the community for the patient's if needed. At times I would have to take a medication cart to administer medications if there was a call out. I would educate staff, conduct in-service training and complete employee evaluations when required.

During the flu season I would administer flu vaccines to all employees, patient's, and ensured proper documentation was completed.
