- Evaluate, assess, prepare and implement evidence-based treatment plans for sick or injured patients and, along with interdisciplinary team, conducts ongoing head to toe nursing assessments as determined by the patients' condition and reprioritizing accordingly
- Implementing safety measures including pressure ulcer, fall, suicide, seizure precautions; NG tube placement and maintenance, Care for wounds of all stages, indwelling and straight catheter insertion and care; IV placement and maintenance; Delegating tasks within scope of practice for other licensed and non-licensed personnel
- Administering medications of various routes according to MD order, including through PEG tubes and maintaining patency of such, colostomy care; preparing patient for various procedures; patient transport; pre-op to post-op care

- Supervising and performing direct patient care including but not limited to taking and monitoring vital signs, initiation and termination of dialysis, documentation, physical assessment of patients and patient treatments, taking and transcription of physician's orders, drawing and documentation of ordered laboratory work

- Keeping PICC lines and central lines intact, including insertion of IVs and managing INT sites and IV pump infusions; Heparin flushes and discontinuing IVs, monitoring for adverse reactions
- Performing total patient assessments in LTAC and developing relevant care plans for rehabilitation
- Administering nebulizer and oxygen treatments to include via tracheostomy, providing tracheostomy care, suctioning, sterile cleaning and preparing for reinsertion, Providing stoma care, and monitoring of patients with mechanical ventilation
- Assess patient condition, review and analyze medical history and lab coagulation values. Scheduling for lab to pick up regular and STAT orders. Verify physicians' orders and patient consent authorization. Recognized for ability to achieve venous access in poor access conditions. Verify blood return and flush to ensure proper midline placement, and confirm PICC placement along with chest x-ray; notify physicians of any abnormal values and parameters
- Inserting and discontinuing indwelling catheters and maintaining patency
- Coordinating the multidisciplinary rehabilitative care of patients and participating as a member of the rehabilitation interdisciplinary team. Contributing information specific to the patient's response to education, medication therapy, pain control, skin condition, bowel/bladder training, and discharge planning
