Manage labor care for early labor through by administering pain meds, epidurals, monitoring contractions and fetal heart tones.

Carry out inductions as related with medications such as pitocin, cervidil, cytotoc, cooks catheter.

Circulate in the OR for C-section, D&Cs and intrauterine transfusion.

Recover post-op patients in the PACU for immediate postpartum period.

Work along side physicians, midwives, pharmacists, social services, and maternal fetal specialists to provide best patient care.
