- Admission and readmission of patients from home, hospital, and discharging of patients to their homes, hospital, and hospice units.
- Administration of medications by different methods to 16 residents.
- Administration of medications was done via trach e.g Nebulizer Treatments e.g Albuterol, ipratropium, P.O by mouth, G-tube, Peg-tube, subcutaneous, intravenous and intra- dermal.
