WHG had the contract initially and the person they had contracted for the position took a GS position so WHG needed someone to finish the contract in order to be compensated for it. I took the position with the understanding that the next company would keep me on. Started the onboarding process with next contractor a few days prior to the end of this contract when was noticed that WHG did not have me finish some of the requirements that VAFB was requiring (like a flu shot in April) to be working there. BLS came due because neither contracting company wanted to be responsible for the cost to cover the requirements nor would 30th medical let me utilize their clinic in order to get

requirements completed. As I was incurring all the costs as personal expenses to work there and I had to find an employment medical clinic on my own so that no MD orders would be needed for the flu shot, that was when 30th medical decided I was taking too long. And halted my return. Loyal source Govt Serv. I signed the contract but never really worked for them.

Started at this Hospital as a CNA and had applied to Nursing school. Became a Unit Clerk right away and monitor observer right away a good thing since accepted into SBCC in October of 1998 2yrs ahead of schedule. All time off from school was working at Marian, usually in the CCU as the UCMO. Once done with nursing school continued with Marian even though other hospitals were offering sign on bonuses, Marian did not. About 1.5 yrs. on telemetry. Transferred to CCU/Cardiac Care Unit spent 7.5 years total there. Then to Trauma/ER the last 5 years. Done almost everything you can do as a nurse with exception of doing chemotherapy drugs. Worked with vent patients who were on Svo2 monitors utilizing Central Line catheters in both neck and groin areas. Use of A-lines on monitor and to do abg's along with using for routine labs. Taking care of patients on IABP, Tracheostomy patients on vents. Patients on several cardiac drips at once such as your post op CABG pt. Had pt. in the ER come in with SCD being resuscitated and actually make it and others who did not.
