Pre-Procedure in neuro required a thorough Neuro Assessment prior to going back to the lab.

Para-Procedure in neuro, the sedation is completely different. The RN would conduct the conscious sedation, or an anesthesiologist would intubate the patient. If intubation was required, the RN would assist with the Arterial Line as well as run co-Ags off of the art line.

Post Procedure for neuro required PACU if the patient was intubated, otherwise, the patient was recovered in the neuro unit, or the neurological bays.
